The Out of School Time (OST) Program Director is responsible for managing partnerships across multiple NKY school districts to ensure high-quality OST program delivery, consistency, and alignment with organizational goals and the Partners for Change OST framework.. The director will lead efforts to implement and maintain effective programming, ensure data-driven decision-making, and support program staff in meeting performance benchmarks. The director will also collect and analyze data and report outcomes to major funders and community stakeholders. This role requires strategic leadership, strong communication skills, and a commitment to providing impactful out-of-school-time experiences for youth.

This role will lead the organization's work to manage a comprehensive Out of School time system, which includes: ensuring consistency and delivery of best practices across all districts participating in OST programs through Partners for Change, providing training and technical assistance to direct service providers at the district level, developing foundational training opportunities for district professionals in the OST field, manage contracts and a network of community partners and stakeholders, and engaging with the broader community to identify ongoing learning opportunities for the organization.
